# WA: Voluntary assisted dying bill update

The Voluntary Assisted Dying (VAD) Bill was passed by WA State Parliament on 10 December 2019. There will be an 18-month implementation period and there is still much work to be done as part of the detailed planning which is required before the laws come into effect. #### Royal Commission into Aged Care Quality & Safety consultation on Aged Care system re-design

The Royal Commission into Aged Care Quality and Safety is inviting submissions from interested individuals and organisations on the future design of the aged care system. The Commission released a consultation paper called Aged Care Program resign: Services for the future exploring options for future design of aged care programs. The model set out in the paper is intended to support people to

pursue and enjoy meaning and quality of life whether in their own home or a residential service. Submissions are sought on key questions about the design of the aged care system. These submissions are an opportunity for interested individuals and organisations to help shape the future of aged care. The Royal Commissioners encourage people to download and read the paper and respond to the design questions through a submission.
